

# CO<sub>2</sub> Budget Source 2024 Interim Control Period Compliance (Sixth Control Period): Fact Sheet

Under each RGGI participating state's CO<sub>2</sub> Budget Trading Program, each "CO<sub>2</sub> budget source" is required to hold one CO<sub>2</sub> allowance for each ton of CO<sub>2</sub> emitted during the preceding three-year control period. The sixth three-year control period began on January 1, 2024 and extends through December 31, 2026 for the states of Connecticut, Delaware, Maine, Maryland, Massachusetts, New Hampshire, New Jersey, New York, Pennsylvania, Rhode Island, and Vermont.

Starting in the third control period, each CO<sub>2</sub> budget source must hold allowances equal to 50 percent of their emissions during each interim control period (the first two calendar years of each three-year control period). Each CO<sub>2</sub> budget source must hold allowances equal to 100 percent of their remaining emissions for the three-year control period at the end of the three-year control period.

The 2024 interim control period began on January 1, 2024 and each  $CO_2$  budget source must hold allowances available in their compliance account for compliance deduction equal to 50 percent of their emissions by March 3, 2025.

The CO<sub>2</sub> budget source interim compliance process occurs in three stages: CO<sub>2</sub> emissions reporting,

#### **Dates to Remember for Sixth Control Period Compliance:**

October 2024: CO2 Allowance Auction 66 Notice Release

**December 4, 2024:** CO<sub>2</sub> Allowance Auction 66 (last quarterly auction to purchase allowances for 2024 interim compliance)

**January 30, 2025:** Deadline to submit Q4-2024  $CO_2$  emissions data to the U.S. EPA

March 3, 2025 (No later than 11:59 PM ET): Deadline to provide CO<sub>2</sub> allowances for 2024 interim control period compliance

#### March 4, 2025:

- CO<sub>2</sub> allowances are automatically deducted from compliance accounts (not including any CO<sub>2</sub> allowances which have already been surrendered)
- 2024 Interim Compliance Report publicly available

**December 2025:** CO<sub>2</sub> Allowance Auction 70 (last quarterly auction to purchase allowances for 2025 interim compliance)

**January 30, 2026:** Deadline to submit Q4-2025 CO<sub>2</sub> emissions data to the U.S. EPA

March 2, 2026 (No later than 11:59 PM ET): Deadline to provide CO<sub>2</sub> allowances for 2025 interim control period compliance

#### March 3, 2026:

- CO<sub>2</sub> allowances are automatically deducted from compliance accounts (not including any CO<sub>2</sub> allowances which have already been surrendered)
- 2025 Interim Compliance Report publicly available

**December 2026:** CO<sub>2</sub> Allowance Auction 74 (last quarterly auction to purchase allowances for sixth control period compliance)

**January 30, 2027:** Deadline to submit Q4-2026 CO<sub>2</sub> emissions data to the U.S. EPA

**March 1, 2027 (No later than 11:59 PM ET):** Deadline to provide CO<sub>2</sub> allowances for sixth control period compliance and to certify compliance

**March 2, 2027:** First, second, third, fourth, fifth and sixth control period CO<sub>2</sub> allowances in compliance accounts are frozen in RGGI COATS

March 2, 2027: Compliance data submitted by sources publicly available

March 2, 2027 – April 1, 2027: States evaluate compliance for each CO<sub>2</sub> budget source

#### April 2, 2027 (Final Compliance True-Up):

• CO<sub>2</sub> allowances are automatically deducted from compliance accounts (not including any CO<sub>2</sub> allowances which have already been surrendered)

Following final compliance true-up, CO<sub>2</sub> allowances in compliance accounts are unfrozen in RGGI COATS (if no allowance shortfall exists after compliance deductions are complete)

compliance activities in the RGGI CO<sub>2</sub> Allowance Tracking System (COATS), and public reporting.

## 1. CO<sub>2</sub> Emissions Reporting

CO<sub>2</sub> budget sources are required to report quarterly CO<sub>2</sub> emissions data to RGGI participating states through the U.S. Environmental Protection Agency's (U.S. EPA's) Clean Air Markets Division (CAMD) Business System in accordance with state CO<sub>2</sub> Budget Trading Program regulations and U.S. EPA regulations at 40 CFR Part 75. Updates made in the CAMD Business System flow directly into COATS periodically. The final quarter of the 2024 interim control period is Q4-2024 (October 1, 2024 - December 31, 2024). The deadline to submit CO<sub>2</sub> emissions data to the U.S. EPA for Q4-2024 is January 30, 2025.

# 2. Interim Compliance Activities in COATS: Acquire & Provide CO<sub>2</sub> Allowances and Run Draft True-Up

 $CO_2$  budget sources are required to acquire and transfer sufficient  $CO_2$  allowances in COATS into their compliance accounts to meet their  $CO_2$  Interim Compliance Obligation (50 percent of the tons of  $CO_2$  emitted during the preceding one-year interim control period, less any exempted emissions deductions) by the allowance transfer deadline of 11:59 PM ET on March 3, 2025. Market participants can obtain  $CO_2$  allowances in quarterly  $CO_2$  allowance auctions or through various secondary markets. Auction 66, to be held on December 4, 2024, is the last  $CO_2$  allowance auction before the end of the 2024 interim control period.  $CO_2$  budget sources must run draft "true-up" in RGGI COATS by 11:59 PM ET on March 3, 2025. This will compare their  $CO_2$  Interim Compliance Obligation to the sum of the  $CO_2$  allowances surrendered and those remaining in the compliance account.

CO<sub>2</sub> budget sources must transfer sufficient CO<sub>2</sub> allowances in their compliance account for deduction in COATS by 11:59 PM ET on March 3, 2025. A CO<sub>2</sub> budget source may also optionally identify specific CO<sub>2</sub> allowances to be used for interim compliance (or "surrender" CO<sub>2</sub> allowances) by using the Compliance Deduction Surrender Transaction in RGGI COATS between January 31, 2025 and March 3, 2025.

Following the allowance transfer deadline, on March 4, 2025 CO<sub>2</sub> allowances will be automatically deducted from the CO<sub>2</sub> budget source's compliance account and transferred to the relevant state's surrender account for interim compliance in accordance with the rules specified in each state's CO<sub>2</sub> Budget Trading Program.

### 3. Public Reporting

On March 4, 2025, the **2024 Interim Compliance Summary Report** will be publicly available in COATS.

At the end of the three-year control period, in March 2027, the 2024 Interim Compliance Summary Report will be archived and replaced by the sixth control period Source-Submitted Compliance Report. Following the states' evaluation of compliance, the sixth control period Source-Submitted Compliance Report will be archived and an updated Compliance Summary Report will be available.
