

## RGGI, Inc. 2025 Proposed Operating Budget

Mr. Bartlett reviewed RGGI, Inc.'s proposed 2025 operating budget.

Ms. Dykes thanked Mr. Bartlett and asked if there were any questions or concerns. Hearing no questions or concerns, Ms. Dykes asked for a motion to approve the 2025 RGGI, Inc. Operating Budget.

Mr. Hoover moved to approve the proposed 2025 RGGI, Inc. operating budget. Mr. Binder seconded this motion. The motion was subsequently unanimously approved.

**RESOLVED**, that the proposed 2025 RGGI, Inc. operating budget is adopted.

## RGGI, Inc. Milestones Update

Mr. McKeon provided a summary of the RGGI, Inc. milestones including:

- control period (the years 2021 through 2023). 99.9% of power sector emission were in compliance, showing the continued success of the compliance process.
- In May RGGI, Inc. released a new interactive Emissions Dashboard on the RGGI website, in response to comments received as part of the ongoing Program Review. The dashboard allows users to explore the mapping of CO<sub>2</sub> emissions and other data from RGGI covered sources over time.
- The 2022 Proceeds Report was released in July 2024. This report is another annual report that
  provides insight into how the RGGI states have utilized the proceeds they have received
  through the quarterly RGGI auctions, and provides some interesting success stories of local
  initiatives funded by the states' RGGI proceeds.
- Regarding state participation in RGGI, throughout 2024 on-going litigation has prevented Pennsylvania from actively participating in RGGI & RGGI Inc. related activities. Final adjudication on Pennsylvania's RGGI regulation is not expected until sometime next year.
- Virginia ceased participation at the end of last year, and completed compliance for the fifth
  control period earlier this year. However, Virginia is working through ongoing litigation
  challenging its withdrawal from RGGI. RGGI, Inc. is following developments in both
  Pennsylvania and Virginia, and will be prepared to work with each state to facilitate their RGGI
  participation, if that becomes appropriate.
- RGGI Inc. conducted four auctions this year, with the milestone of our 66<sup>th</sup> consecutive successful RGGI auction being completed just last week.
- Life-to-Date RGGI Inc. has overseen auctions that have sold over 1.4 Billion allowances, with revenue to the states over \$8.6 Billion.
