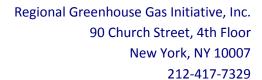

#### 1. Introduction

The proposed *RGGI*, *Inc.* 2018 Operating Budget was developed by RGGI, Inc. in consultation with BTQ Financial, the RGGI, Inc. fiscal operations service provider, and approved for circulation by the Finance Committee and the Executive Committee.

The proposed *RGGI*, *Inc.* 2018 Operating Budget is shaped by two main factors. First, the need to budget for appropriate contingencies so the Participating States have reliable not-to-exceed numbers for contracting purposes. Second, any savings in expenses at the end of each year are credited towards state payments to RGGI, Inc. for the subsequent year.

### 2. 2018 Budget and 2017 Year End Forecast Summary

The 2018 RGGI, Inc. Operating Budget is divided into two major categories of expense including:

- Contractor Expenses
- Operating Expenses

Operating expenses is then further subdivided into Personnel (PC) and Other than Personnel Costs (OTPC).

As show in Table 1, RGGI, Inc. is proposing a 2018 Operating Budget of \$2,390,286.

The proposed 2018 budget is in line with recent RGGI, Inc. budgets (slightly under the 2017 budget of \$2.463 million; slightly over the 2016 budget of \$2.303 million).

As shown in Table 2, RGGI, Inc. is projecting a 2017 Year-End Forecast (projected total annual expenses) of \$2,224,544, a figure \$239,084 below the 2017 Budget of \$2,463,628. This savings will be applied to state payment obligations for 2018.

Contractor expenses include projected costs for RGGI, Inc. contractors to support implementation and administration of:

- A secure and sturdy platform RGGI COATS for the CO<sub>2</sub> allowance and emissions tracking system (CSRA);
- A robust and sound structure for hosting the RGGI quarterly CO<sub>2</sub> allowance auctions (EnerNOC)
- Independent market monitoring of the performance and efficiency of the CO<sub>2</sub> allowance auctions and the secondary CO<sub>2</sub> allowance market. (Potomac)
- Technical Analysis and Evaluation, which includes costs to support modeling for ongoing program planning and support. (IPM)

The Contractor Expense budget for 2018 is 11% lower than Contractor Expenses for 2017, largely due to decreases in Technical Analysis and Evaluation and to a lesser degree in RGGI COATS.

The Operating Expense budget for 2018 is 7.5% greater than Operating Expenses for 2017, largely due to Increases in Personnel, and restoring the Professional Services Reserve.
