The Regional Greenhouse Gas Initiative (RGGI) participating states have initiated the Third Program Review to conduct a comprehensive review of the successes, impacts, and design elements of their CO₂ budget trading programs.

As part of the Third Program Review, the RGGI states will hold a public meeting to discuss considerations for the electricity sector analysis that will be a key component of Program Review. The states will discuss the Integrated Planning Model (IPM) that will be used to conduct the analysis, and draft approaches, considerations, and questions to help determine the assumptions to be used in modeling scenarios.
